ACKNOWLEDGEMENT OF SERVICES AND FEES SUBJECT: SELF-IMPROVEMENT PROGRAM

I, the undersigned, acknowledge that I understand and agree to the following:

I agree to pay Norman Plotkin a fee of \$200 per session, or the quoted amount for the selected package of sessions.

I also agree to pay you for your services, **in full**, either prior to, or on the date of the first session.

I agree to give you 24 hours notice for all cancellations or changes of scheduled appointments. I understand that missing a scheduled appointment without prior cancellation, or canceling with less than 24 hours notice, may be charged to me at the current full rate.

I understand that the program of conditioning offered by you will include a determined number of private sessions that is dependent on my individual needs. Additional Conditions:

I further understand that there are no refunds for services already rendered. I understand that when buying a discounted package of sessions, if the package is not completed, the number of sessions that were completed will be billed at the single session price of \$200, and any package refund will be for an amount less the \$200 times the number of completed sessions.

If a six-month or twelve month package is purchased, in any month that the four or five sessions are not used, sessions do not roll over and it is the responsibility of the client to schedule and attend the allowed number of monthly sessions.
